

**ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS**

The name of this corporation is B & S Janitorial Services, Inc., and its principal place of business shall be located at 1406 Wickford Place, Brandon, FL 33511.

**ARTICLE II - DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue one hundred (100) shares of common stock at one dollar and zero cents (\$1.00) par value, which shall be designated as "Common Shares."

**ARTICLE VII - DIRECTORS**

Initially, this corporation shall have two (2) Directors who shall serve until their successors shall be elected/appointed at the first meeting of the stockholders and thereafter this corporation shall have no less than two (2) directors constituting the initial Board of Directors. The number of






