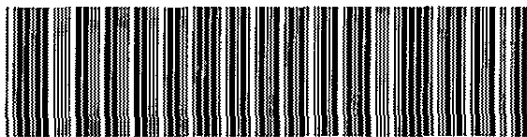

The undersigned, acting as Incorporator of a corporation, pursuant to chapter 607 and /or Chapter 621, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be: Everyday's Saturday, Inc.

ARTICLE II

The principal office of the business shall have the address 6713 Oakmont Way, Bradenton, Florida 34202

ARTICLE III

The general purposes for which the corporation is organized are:

1. To engage in a food service business.

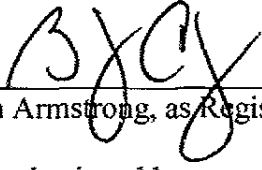
