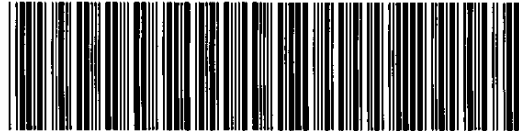

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Quality Build-Out Corporation.

ARTICLE II

The street address of the principal office of the corporation is 4149 North Dixie Highway, Pompano Beach, FL 33064.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 1,000, all of which shall be common shares.

ARTICLE IV

The initial street address of the Corporation's registered office is 1574 Village Square Boulevard, Suite 100, Tallahassee, FL 32309. The initial registered agent for the Corporation is UCC Filing & Search Services, Inc.


