ARTICLES OF INCORPORATION
OF
AVENEL FAMILY CORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation is: AVENEL FAMILY CORPORATION. The principal office of the Corporation is 5586 South Orange Blossom Trail, Intercession City, Florida 33848, and the mailing address of the Corporation is 5586 South Orange Blossom Trail, P.O. Box 713, Intercession City, Florida 33848-0713.

Article 2. Duration. The duration of the Corporation is perpetual.

Article 3. Purpose. The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

Article 4. Capital Stock. The aggregate number of shares which the Corporation shall have authority to issue is Ten Thousand (10,000) shares at a par value of One Cent (\$0.01) per share.

Article 5. Initial Registered Office and Agent. The street address of the initial Registered Office of the Corporation is 5586 South Orange Blossom Trail, Intercession City, Florida 33848, and the name of the initial Registered Agent at that address is Marisol Fernandez.

Article 6. Initial Board of Directors. The number of Directors constituting the initial Board of Directors is two (2). The number of Directors may be increased or decreased from time to time in accordance with the Bylaws but shall never be less than one. Article 7. Officers. The names of the initial officers of the Corporation are:






