ARTICLES OF INCORPORATION

OF

ARTICLE I NAME

The name of this Corporation is **OML** PROPERTY INVESTMENTS and its mailing address is c/o Corporate Process Services, Inc. 2300 Coral Way Suite 201, Miami, Florida 33145.

ARTICLE II NATURE OF BUSINESS


