**ARTICLES OF INCORPORATION
OF
THE FLOORING SHOP, INC.**

The undersigned, acting as the incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
Name of Corporation**

The name of the corporation is "THE FLOORING SHOP, INC."

Commencement And Duration of

Capital Stock**
