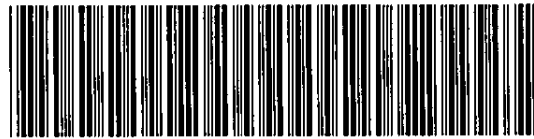

Pursuant to Sections 607.1006 and 607.1007, Florida Statutes (2012), the undersigned member of the Board of Directors of Hiram A. Cuevas, M.D., P.A. ("Corporation") propose, and the shareholder of the Corporation hereby approves and adopts, the following Amended and Restated Articles of Incorporation which amend and restate the initial Articles of Incorporation filed with the Secretary of State for the State of Florida on September 22, 2006 and assigned document number PO6000122622.

**ARTICLE I**  
**AMENDED NAME**

The name of the Corporation is **HIRAM A. CUEVAS, M.D., INC.**

**ARTICLE II**  
**PRINCIPAL ADDRESS**

The street address of the principal office of the Corporation is 7926 W. Hillsborough Ave., Suite A, Tampa, Florida 33615.

**ARTICLE III**

**AMENDMENT**

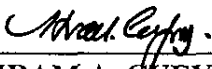
