It was found while trying to submit Poe Electric Inc.'s Annual Report for 2020 with Florida's Department of State that our account had been revoked. Poe Electric Inc. has filed Annual Reports yearly with Florida since 2003. In 2018 it would appear our account was taken over by a company sharing our name. The contact information and FEI/EIN number were all changed to this other company's info and the report for the year was amended two times. The Officer details remained under Eddie and Tina Poe's names but the address had been modified to the address in Boynton Beach, FL. We did not receive notification of any changes or of revocation as the info was not our own. Document Number F03000000213 has since 2003 been our filing. The online system is giving the only option to rectify the situation to be filing for reinstatement and paying the fine of \$900. Our concern is there is no way of ensuring once we have this all cleared that this will not happen again since you can change and alter any of this info online. Also, it does not feel justified to require reinstatement since our account was taken over by a company that was seemingly working illegally in the state. Please advise on proper steps to take to have this issue resolved.

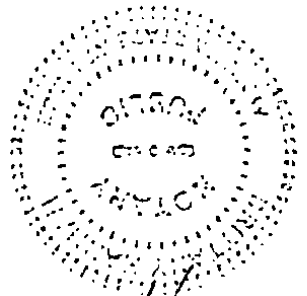
