The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE 1

Name

The name of the corporation is Dot's Hair Salon & More, Inc.

ARTICLE II

Principal Office
