**ARTICLES OF INCORPORATION
OF
SOUTHWEST INNOVATIONS CONSTRUCTION, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is Southwest Innovations Construction, Inc.

ARTICLE II

The existence of the corporation shall begin on September 22, 2006

ARTICLE III

The street address and mailing address of the principal office of the Corporation is 24549 Nova Lane, Port Charlotte, Florida 33980.


