**ARTICLES OF INCORPORATION
OF
MARCO A. NOVA, M.D., P.A.**

The undersigned, acting as incorporator of MARCO A. NOVA, M.D., P.A., under the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation is MARCO A. NOVA, M.D., P.A.

ARTICLE II. ADDRESS

The mailing and business address of the corporation is:

ARTICLE III. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE IV. PURPOSE

The corporation is organized to engage in the practice of medicine and in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE V. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1,000 shares of common stock having a par value of \$0.01 per share.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VII. INITIAL BOARD OF DIRECTORS


ARTICLE IX. BYLAWS
