#### ARTICLES OF INCORPORATION

OF

### PROFESSIONAL IMAGE DESIGN, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE ONE: NAME: The name of the corporation shall be PROFESSIONAL IMAGE DESIGN, INC.

ARTICLE TWO: <u>DURATION</u>: The term of existence of the corporation is perpetual.
