The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is Custom Furnishings by Design, Inc. Principal place of business is 124 Weston Rd, Weston, FL 33326

ARTICLE II: DURATION

The existence of the Corporation shall commence with the filing of these Articles. The duration of the Corporation is perpetual.

ARTICLE IV: SUBCHAPTER S CORPORATION
