ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the Corporation is Accordion Shutters by Design, Inc. Principal place of business is 124 Weston Rd, Weston, FL 33326
