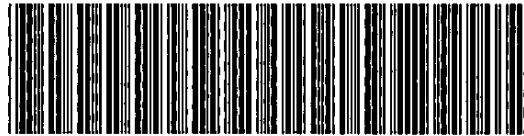

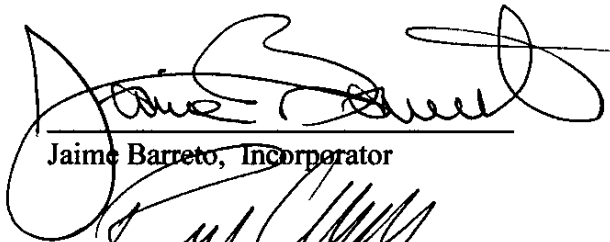
**ARTICLE EIGHT: FOR PROFIT.**

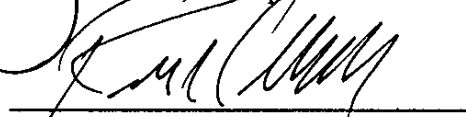

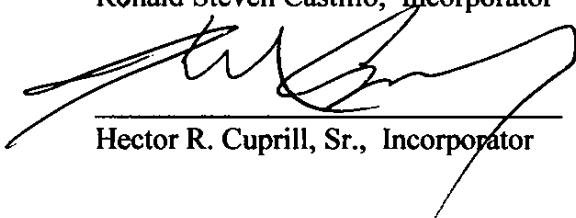
