The undersigned, for the purpose of forming Corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation.

ARTICLES I - NAME

The name of the Corporation is **DOUBLE EAGLE PRESSURE CLEANING INC.**

ARTICLES II - TERM OF EXISTENCE

The duration of the Corporation is perpetual.
