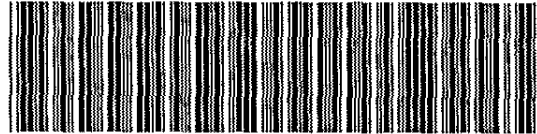



NAME

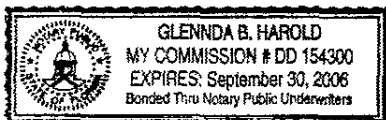
