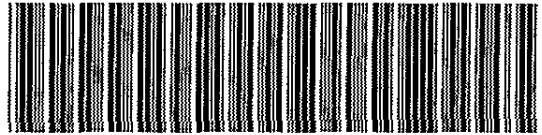

Articles of Incorporation Of

F&J DRYWALL & FINISHING, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

Article I -Name

The name of the corporation is: **F&J DRYWALL & FINISHING, INC.**

Article II -Duration

The duration of the corporation is perpetual.

Article III -Purpose

The General purposes for which the Corporation is organized are the following:
