

ARTICLES OF INCORPORATION CHEN MEDICAL NORTH MIAMI BEACH, INC.

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I NAME.

The name of the corporation shall be: Chen Medical North Miami Beach, Inc.

ARTICLE II. ADDRESSES.
