ARTICLES OF INCORPORATION
OF

The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I. NAME.

The name of the corporation shall be: Chen Medical North Miami Beach, Inc.

ARTICLE II. ADDRESSES.

The address of the principal office of this corporation shall be 2668 Riviera Manor, Weston, FL 33332 and the mailing address of the corporation shall be the same. The Board of Directors may from time to time move the principal office to any other address in Florida.


