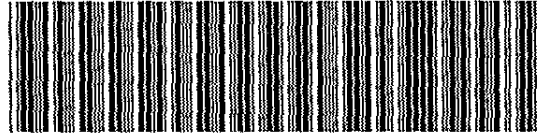

OF

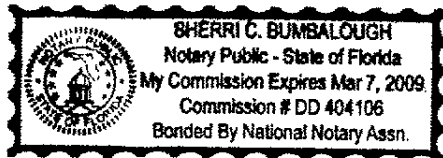
