

**ARTICLES OF INCORPORATION
OF KRIS WINTERS DESIGNS, INC.**

ARTICLE I – NAME

The name of the corporation is Kris Winters Designs, Inc.

ARTICLE II – PRINCIPAL OFFICE

The principal office for the corporation as well as the mailing address is 8188 Lake Serene Drive, Orlando, Florida, 32836.

ARTICLE III – PURPOSE AND POWERS

The general purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Business Corporation Act. The corporation shall have the powers granted to business corporations under the Laws of the State of Florida, except such powers as are inconsistent with the express provisions of these Articles.

ARTICLE IV – SHARES AND SHAREHOLDERS

The maximum number of shares of capital stock that the corporation is authorized to have outstanding at any one time is 1,000 shares of common stock having a par value of \$1.00 per share. The corporation is authorized to issue a single class of common stock, and all issued stock shall be held of record by not more than 35 persons. Stock will be issued and transferred only to natural persons, estates, or a trust defined in 26 U.S.C.A. § 1361(c)(2) (or its successor section). In addition, no stock shall be issued or transferred to a nonresident alien.

ARTICLE V – PREEMPTIVE RIGHTS

Each holder of any of the shares of capital stock in the corporation, upon the issuance of additional shares, shall be entitled to a preemptive right to purchase a pro rata share thereof at the price which is offered to others.

ARTICLE VI – INCORPORATORS

The name and address of the incorporator of the corporation is Kristianna L. Winters, 8188 Lake Serene Drive, Orlando, Florida, 32836.

ARTICLE VII - NO BOARD OF DIRECTORS

The corporation shall have no board of directors, and all of the corporate powers shall be exercised by, and the business and affairs of the corporation shall be managed under the direction of the shareholder or shareholders or such persons the shareholder or shareholders may designate as officers.

ARTICLE VIII - INDEMNIFICATION OF OFFICERS AND OTHERS

The corporation shall indemnify any person who was or is a party or is threatened to be made a party to any threatened, pending, or completed action, suit, or proceeding, whether civil or criminal, administrative or investigative, by reason of the fact that he or she is or was an officer, shareholder, employee, or agent of the corporation, or is or was

serving at the request of the corporation. Such indemnification shall be against expenses (including attorneys' fees), judgments, fines, and amounts paid in settlement, actually and reasonably incurred by him or her in connection with such action, suit, or proceeding, including any appeal of such action, suit or proceeding.

ARTICLE IX – DURATION

The corporation shall have a perpetual existence.

ARTICLE X – AMENDMENT

The corporation reserves the right to amend, add to, or repeal any provision contained in these articles of incorporation in a manner consistent with Florida law.

ARTICLE XI - INITIAL REGISTERED OFFICE AND REGISTERED AGENT

The street address of the corporation's initial registered office is 8188 Lake Serene Drive, Orlando, Florida, 32836. The name of the corporation's initial registered agent is Kristianna L. Winters.
