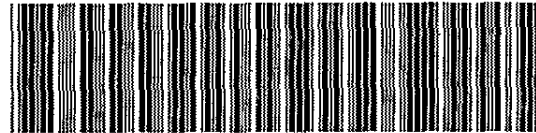

OF

ARTICLE I • NAME

The name of this Corporation is Peter V. Sesso, Inc. The principal office mailing address is 1211 Pine Point Road, Singer Island, FL. 33404.

ARTICLE II • DURATION

This Corporation shall exist perpetually commencing on September 30, 2006.

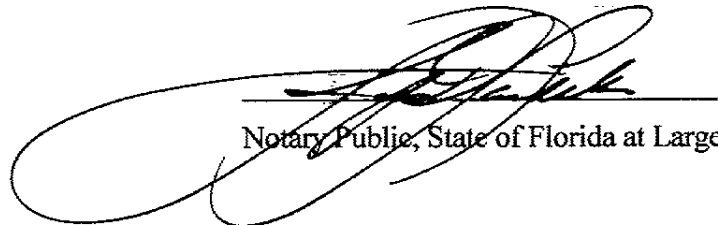

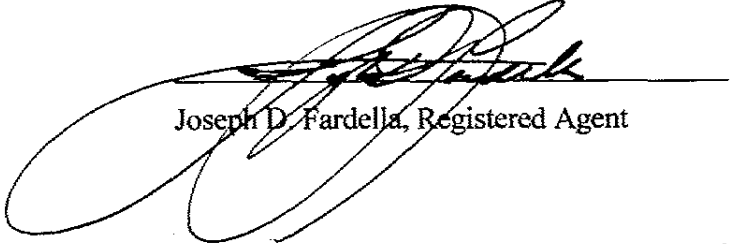
