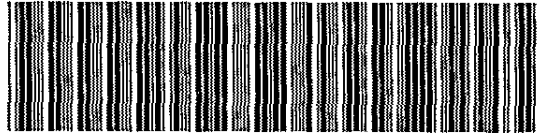



The undersigned incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

ARTICLE I

The name of this corporation is Turf Towing, Inc.

These Articles of Incorporation may be amended in the manner provided by law.

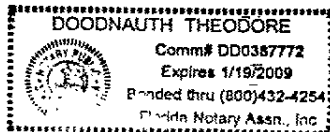
