ARTICLES OF INCORPORATION
OF

ARTICLE I
Name

The name of the corporation is GHS FLORIDA GROUP, INC.

ARTICLE II
Duration

This corporation shall have a perpetual existence, unless dissolved according to law, commencing on the 28th day of SEPTEMBER, 2006.

ARTICLE III
Purpose
