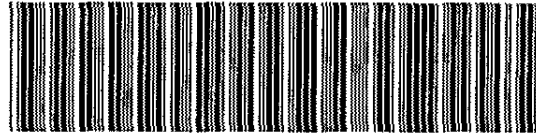

Article I

*Name.* The name of this Corporation is My Dough Boy, Inc.

Article II

*Principal Office.* The address of the principal office of the Corporation is 1600 First Avenue South, Steinhatchee FL 32359, which mailing address is P.O. Box 1059, Steinhatchee FL 32359).

Article III

*Duration.* The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV

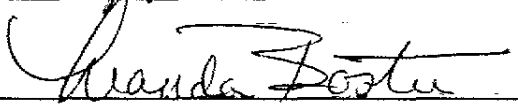
