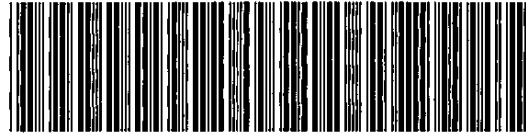

ARTICLE I. NAME.

The name of the corporation shall be
