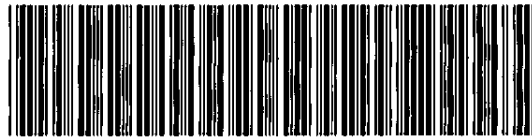

Joseph L. Conti

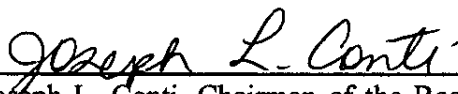
