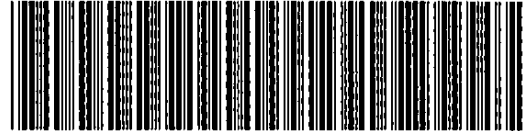

The undersigned subscriber of these Articles of Incorporation, a natural person competent to contract and legally authorized to practice law in the State of Florida, hereby proceeds to form a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following Articles of Incorporation for the Corporation:

**ARTICLE I**

**Name**

- 1.1 The name of the Corporation is J & J CUSTOM STONE CREATIONS, INC.

**ARTICLE II**

**Duration**

- 2.1 This Corporation shall have perpetual existence commencing in the date of filing of these Articles of Incorporation with the Department of State of Florida.

**ARTICLE III**

**Purpose**

- 3.1 To engage in the practice of stone masonry as a professional service corporation and to provide services incident thereto.
- 3.2 To own property, to enter contracts and carry on any activity necessary or incidental to the accomplishment or furtherance of the purpose of this Corporation.
- 3.3 The services of this Corporation which consist of the practice of stone masonry shall be carried out only through officers, employees and agents who are licensed in the State of Florida to engage in the practice of stone work.
- 3.4 To do everything necessary, proper or convenient for the accomplishment of the purpose herein set forth, and to every other act incidental thereto which is not forbidden by the laws of the State of Florida or by the provisions of these Articles of Incorporation.

**ARTICLE IV**

**Capital Stock**

- 4.1 The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time is 7500 shares having a value of \$1.00 per share. Such shares shall be of a single class of common stock. None of the shares of the Corporation may be issued to anyone other than individual who are active members of the legal profession in good standing.

**ARTICLE V**

**Initial Registered Office and Agent and  
Principal Office and Mailing Address**

**ARTICLE VI**

**Directors**

- 6.1 This Corporation shall be managed by a Board of Directors of at least one (1) Director. No person shall serve as a Director of the Corporation unless the person is duly licensed to practice law. The Directors shall be elected by the shareholders of the Corporation. **Disqualifications**


