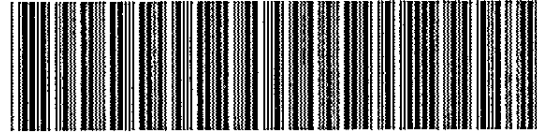

The undersigned, being a natural person of the age of eighteen years or more, and acting as the Incorporator of a corporation to be organized pursuant to the laws of the State of Florida, does hereby adopt the following Articles of Incorporation:

**ARTICLE I
