**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
HONDAJET SOUTHEAST, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article 1 of the Articles of Incorporation is amended to read:

**Article 1
Name and Principal Office**

The name of this Corporation shall be **FlightJets Southeast, Inc.** The principal place of business and mailing address of this Corporation shall be 3256 Capital Circle S.W., Tallahassee, Florida 32310-8723.

2.
