The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit under the laws of the State of Florida.

## <u>ARTICLE I - NAME OF CORPORATION</u>

The name of this corporation shall be Shands Roofing, Inc.

## **ARTICLE II - DURATION**

This corporation shall exist perpetually.
