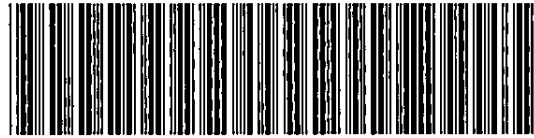

**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
PIPERJET SOUTHEAST, INC.**

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article 1 of the Articles of Incorporation is amended to read:

**Article 1  
Name and Principal Office**

The name of this Corporation shall be **FlightJets East, Inc.** The principal place of business and mailing address of this Corporation shall be 3256 Capital Circle S.W., Tallahassee, Florida 32310-8723.

2. Pursuant to Sections 607.1003 and 607.1006, Florida Statutes, and in accordance with the Articles of Incorporation of the Corporation, by unanimous vote the Shareholders holding shares of the Corporation's common stock authorized and consented in writing on November 29, 2007, to the filing of these Articles of Amendment to Articles of Incorporation.
