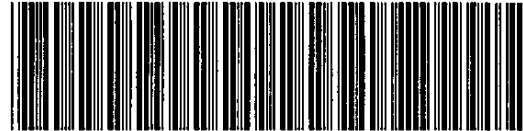

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the law of the State of Florida.

ARTICLE 1. - NAME AND ADDRESS

The name of this corporation is CBP CONSTRUCTION, INC., a Florida corporation, and the principal office is located at 18501 Murdock Circle, Suite 101 Port Charlotte, Florida 33948.

ARTICLE 2. - DURATION OF CORPORATION EXISTENCE

The corporation shall exist perpetually.

ARTICLE 3. - PURPOSES






