The undersigned incorporator hereby subscribes to these Articles of Incorporation to incorporate Silent Creek, Inc. (the "Corporation"), under the Florida Corporation Act (Chapter 607, Florida Statutes) and in accordance with section 607.0202, Florida Statutes.

1. Name. The name of the Corporation is Silent Creek, Inc.
2. Mailing Address and Street Address of Principal Office. The mailing address and street address of the Corporation's principal office is Two North Tamiami Trail, Suite 506, Sarasota, Florida 34236.
3. Name and Street Address of Initial Registered Agent. The name of the initial registered agent of the Corporation is Thomas R. Conklin, and the address of the Corporation's initial registered office is Two North Tamiami Trail, Suite 506, Sarasota, Florida 34236.

By execution hercof, the underlined acknowledges that he is familiar with the obligations imposed on the position of registered agent by the Florida Corporation Act and hereby accepts the appointment as the initial registered agent of the Corporation.


4. Authorized Shares. The Corporation is authorized to issue 100 shares of common stock having a par value of \$1.00 per share. No share shall be issued except upon payment to the Corporation of the par value of the share in cash or other consideration permitted by law as payment for shares.

5. Bylaws. The initial bylaws of the Corporation shall be adopted by the incorporator or the board of directors. The power to alter, amend or repeal any bylaw shall be vested in the shareholders, except to the extent delegated by the shareholders to the board of directors.

6. Incorporator. The name and address of the incorporator of the Corporation is Thomas R. Conklin, Two North Tamiami Trail, Suite 506, Sarasota, Florida 34236.

7. Effective Date. In accordance with section 607.0123, Florida Statutes, the Corporation's existence shall begin at the date and time these Articles of Incorporation are filed, as evidenced by the Department of State's date and time endorsement.
