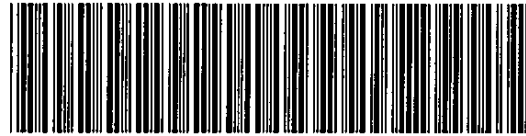





ARTICLE IX - AMENDMENTS






