ARTICLES OF INCORPORATION OF J FINCH, INC.

ARTICLE 1 - NAME

The name of this corporation is J FINCH, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
