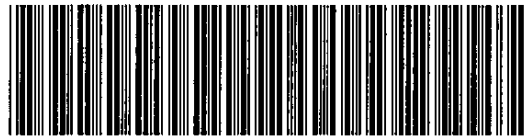

ARTICLE IV: The amount of total stock this corporation is authorized to issue is One Hundred (100) shares with no par value per share.

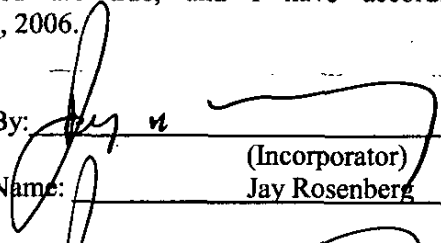

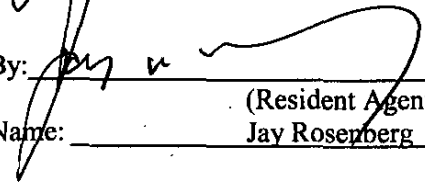
