The purpose or purposes for which this corporation is formed, are as follows, to wit:

To provide outplacement consulting services:

To provide accounting and tax services to CPA's and other financial planners

To provide accounting and tax services directly to the public.

To establish and distribute a quarterly magazine to be made available directly to the general public.
