

STATE OF FLORIDA ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

AMERICAN BUILDING CO. AND MAINTENANCE SERVICE, INC., A FLORIDA CORPORATION



FIRST: That a meeting of the Board of Directors of AMERICAN BUILDING CO. AND MAINTENANCE SERVICE, INC., A FLORIDA CORPORATION, resolutions were duly adopted, on this 12th day of October, setting forth proposed amendments to the Articles of Incorporation of said corporation, declaring said amendments to be advisable and calling a meeting of the stockholders of said corporation for consideration thereof. The resolutions setting forth the proposed amendments are as follows:

RESOLVED, that the Articles of Incorporation of this corporation be amended by changing the Article thereof numbered "Article IV" so that, as amended, said Article shall be and read as follows:

RESOLVED, that the Articles of Incorporation of this corporation be amended by changing the Article thereof numbered "Article IX" so that, as amended, said Article shall be and read as follows:

The Corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

SECOND: That thereafter, pursuant to resolution of its Board of Directors, a special meeting of the stockholders of said corporation was duly called and held upon notice in

accordance with Section 607.0702 of the FLORIDA Business Corporation Act at which meeting the necessary number of shares as acquired by statute were voted in favor of the amendment,
