ARTICLES OF INCORPORATION
OF
AMERICAN BUILDING CO. AND MAINTENANCE SERVICE, INC.,
A FLORIDA CORPORATION**

AMERICAN BUILDING CO. AND MAINTENANCE SERVICE, INC., A FLORIDA CORPORATION, a corporation organized and existing under and by the virtue of the FLORIDA Business Corporation Act, does hereby certify:

FIRST: That a meeting of the Board of Directors of AMERICAN BUILDING CO. AND MAINTENANCE SERVICE, INC., A FLORIDA CORPORATION, resolutions were duly adopted, on this 12th day of October, setting forth proposed amendments to the Articles of Incorporation of said corporation, declaring said amendments to be advisable and calling a meeting of the stockholders of said corporation for consideration thereof. The resolutions setting forth the proposed amendments are as follows:

RESOLVED, that the Articles of Incorporation of this corporation be amended by changing the Article thereof numbered "Article IV" so that, as amended, said Article shall be and read as follows:

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100,000,000 shares of common stock having a par value of \$0.01 per share.

RESOLVED, that the Articles of Incorporation of this corporation be amended by changing the Article thereof numbered "Article VII" so that, as amended, said Article shall be and read as follows:

The Board of Directors shall consist of not less than one (1) Director and not more than fifteen (15) Directors and the total number of Directors may from time to time be increased or decreased in such manner as is described in the Company's By-Laws, provided, however, that the number of Directors shall not be reduced to less than one (1).

RESOLVED, that the Articles of Incorporation of this corporation be amended by changing the Article thereof numbered "Article IX" so that, as amended, said Article shall be and read as follows:

The Corporation shall indemnify any officer or director or any former officer or director, to the full extent permitted by law.

SECOND: That thereafter, pursuant to resolution of its Board of Directors, a special meeting of the stockholders of said corporation was duly called and held upon notice in

accordance with Section 607.0702 of the FLORIDA Business Corporation Act at which meeting the necessary number of shares as acquired by statute were voted in favor of the amendment.

THIRD: The amendments were approved by the shareholders. The number of votes cast for the amendments by the shareholders were sufficient for approval.
