# ARTICLES OF INCORPORATION

### ARTICLE I – NAME

The name of this Corporation is: DOUBLE J ALUMINUM CONCEPTS INC.

## ARTICLE II - DURATION

This Corporation is to exist perpetually. It shall commence existence on the date of filing of these Articles of Incorporation.
