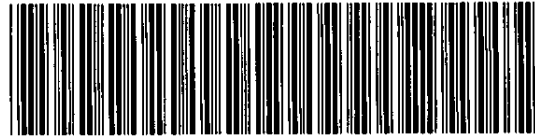

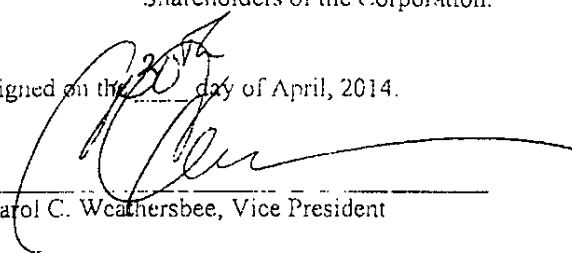
Under §607.1403 of the Florida Business Corporation Act, this Corporation submits these Articles of Dissolution.
