Anthony C. Bailey

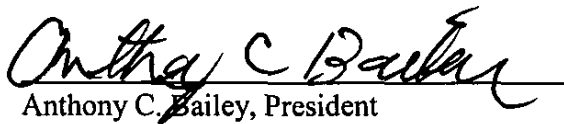
