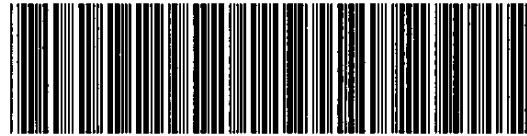

**ARTICLES OF INCORPORATION  
OF  
SHOOTING STAR SCHOOL OF PERFORMING ARTS, INC.**

The undersigned acting as incorporator of this corporation pursuant to Chapter 607 of the Florida statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation.

**ARTICLE I- NAME AND ADDRESS OF CORPORATION**

The name of the corporation shall be Shooting Star School of Performing Arts, Inc. The address of the corporation shall be 1001 Ginger Spice Lane, Ocoee, Florida 34761.

**ARTICLE II-TERM OF EXISTENCE**

This corporation shall exist perpetually.

**ARTICLE III-NATURE OF BUSINESS**
