The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the corporation is: Marianna Sports Massage, Inc.

ARTICLE TWO

The street and mailing address of the initial registered and principal office of the corporation is 2584 Governors Court, Marianna, Florida 32446, and the name of its initial registered agent at such address is Lisa deBrauwere.

ARTICLE THREE

The aggregate number of shares which the corporation is authorized to issue is one hundred shares. Such shares shall be of a single class, and shall have a par value of one (\$1.00) per share. The initial issue of such one hundred share shall be to Lisa deBrauwere.

The corporation is authorized to issue only one class of stock and all issued stock shall be held of record and by no more than ten individuals who are not nonresident aliens.

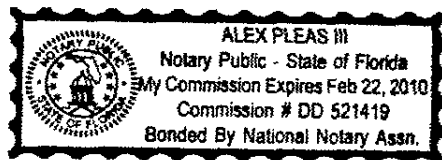
