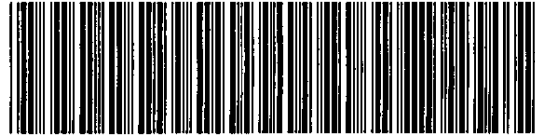

**ARTICLE ONE**

The name of the corporation is **JON KLEIBER REAL ESTATE, INC.**

The period of its duration is perpetual.
