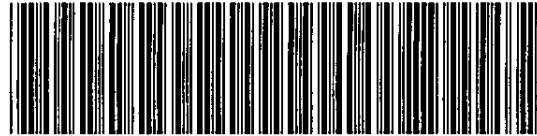

The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida Business Corporation Act.

ARTICLE I – NAME OF CORPORATION

The name of the corporation is: Lamazares Multiservices, Inc.

ARTICLE II – DURATION

The duration of the corporation is perpetual.

ARTICLE III – GENERAL PURPOSE

- 1. The operation and management of the Corporation.**
