Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, Top Shop Marketing, Inc., a Florida corporation (the "Corporation"), does hereby certify as follows:

1. The name of the Corporation is Top Shop Marketing, Inc.
2. The original Articles of Incorporation of the Corporation were filed on October 16, 2006 with an effective date of January 1, 2007, and assigned Document No. P06000131261 (the "Articles").
3. The following amendment to the Articles was adopted by the sole Shareholder and the sole Director of the Corporation by written consent dated September 26, 2024, in accordance with the provisions of Sections 607.0821 and 607.0704 of the Florida Statutes. 4. Article I of the Articles is hereby amended in its entirety and replaced with the following:


"ARTICLE I - NAME
