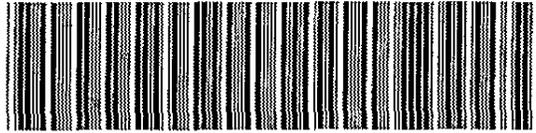

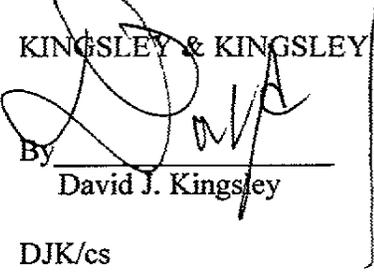

**ARTICLE I**

**NAME**

The name of this corporation is FLEXIBLE FABRICATORS, INC.

**ARTICLE II**

**DURATION**

This corporation shall have perpetual existence.

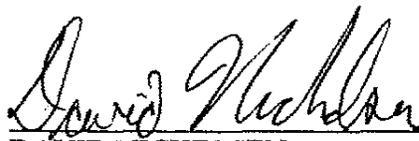

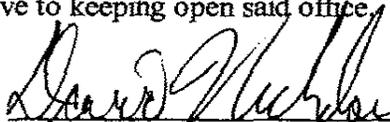
